These research topics has been also an important part of the research activity carried out with the Institute for World Economy. In 2023 I coordinated a team of researchers on a study related to: Systemic changes in the world economy as result of the new geopolitical realities and of the measures for climate changes mitigation.

Based on all these activities I could obtain a balanced view on the costs and benefits of the transition to a green economy and I could identify 3 main objective constraints in designing of any strategy for transition to a green economy:

- The necessity to secure continuously the necessary flows of energy ad raw materials that allow the functioning of economies and societies;
- The necessity to take into account the available scientific and technological knowledge and resources as well as the time necessary for implementation of new technologies.
- The necessity to secure a just transition, taking into account the different historical responsibilities related to climate change as well as the present day resources (human, material, technological) available to developing/emerging and developed countries.

The rest of decade until 2030 will witness several transitions that will manifest in different formats and with different intensities for different groups of countries. The new geopolitical realities, such as the emergence of Global South or BRICS+ will require a nuanced approach to the objective requirements of mitigating climate change or redefining the international economic order.
